READ FIRST EXPLANATION/INSTRUCTIONS

Dear Proprietor:

Enclosed you will find **four** documents which require **action** on your part.

The documents you should read first are the **Special District Meeting Warrant** and **Annual District Meeting Warrant**. It explains in article form what district business will be conducted on June 10^{th} .

The **Special District Meeting** is scheduled to begin at 12:05 PM. This meeting enables the prudential committee on your authority to re-allocate or transfer unexpended funds to cover expenses in categories that need additional money. All unexpended money left over at the end of the fiscal year will be carried forward into the next fiscal year. **Think of it as balancing your checkbook**.

The **Annual District Meeting** will take place at 1:00 PM. These articles cover a variety of topics from the election of the prudential committee members, to budgeting funds to cover FY2018 expenses, to updating bylaw language and to dealing with proprietors who have requested to be excluded.

Next review the SFLD Projected Operating Budget for FY2018. It covers the anticipated costs in each expense category. The projected budget is a bit higher this year due in part to mandatory Office of Dam Safety reports and the development of an Emergency Action Plan in the event of a catastrophic dam failure, final engineering design specifications and environmental permitting. Anticipated costs associated with the Lancelot dam repair appear to have stabilized in the current economic climate but as with any project of this magnitude, unanticipated issues could change the eventual cost. Last year, the district approved projected funding for Lancelot dam, land acquisitions, but could not move forward until local and state agencies received the proper authorizations. The Town of Becket Select Board at its Annual Town Meeting did approve the transfer of two critical land parcels that abut the Lancelot Dam. Easement issues surrounding the lakes outlet located on proprietor's private property have been resolved. Last fall the prudential committee, with substantial help from the project's engineering firm, Tighe & Bond, applied for a state grant to cover a major portion of the design costs. In November of 2016, the Commonwealth, through the Secretary of Energy and Environmental Affairs, awarded the District \$52,500 to take crucial measures to rebuild the Lancelot Lake dam and to prepare it for extreme weather events and improve the resiliency of this vital infrastructure component. The senior engineer updated the prudential committee over the course of the winter when in February, a dive team explored the condition and stability of the existing low level outlet which had been rendered nonoperational nearly 20 years ago. Once the engineering design is complete, the prudential committee plans to apply for a construction grant and/or low interest loan from the State.

Last is the **Proxy**. The prudential committee would like all proprietors to attend the Annual District Meeting and voice their opinions and vote on each warrant article, however, they also realize that this is impossible for many for a variety of reasons. The **proxy** gives you a chance to participate in the decision making process in that you can assign your vote to an individual or group of individuals who will vote on your behalf.

If you cannot attend, **sign and return** your **proxy** in the enclosed return envelope or give it to someone you know who will attend the meeting. The proxy holder(s) will vote on your behalf. Mailed proxies need to reach the Becket Post Office not later than **Friday**, **June 9**th to be counted. **Please don't forget the postage**.
