#### **Budget Season is upon us**

Hello again. Thank you for the warm welcome and support so far as I have now been here a month. We all hope that the weather is changing and spring and summer are on the way. This also means that budget season is here. Departments and Town Hall staff have been working diligently to get everything ready. We are working with two groups, the Edward J. Collins, Jr. Center for Public Management - UMass Boston and ClearGov.com to be more transparent and create a Town Meeting Budget Presentation that are both user friendly and informative.

Interim Town Administrator Bob Markel secured grants to cover the costs of both organizations work. The Collins institute will assist in creating the Town Meeting budget presentation. We hope to receive a certification, based on the presentation from the Government Financial Officers Association (GFOA). ClearGov.com is a website where we will upload financial data so that townspeople and others can better see the financial status of the Town. This will include greater information regarding revenues and expenditures. We hope to see the information ready to go live at the beginning of April.

Finally, as a reminder, April 6th will be both the Town Caucus and the Wahconah High School Building project vote, so please be sure to exercise your right to vote.

#### THE SELECTMEN'S COLUMN

Is spring just around the corner? After this winter of snow, ice, rain and mud we can only hope that the weather will improve.

The Special Town Meeting in January passed a revised Solar By-law to bring us into compliance with our Green Communities designation which will allow us to pursue additional Green Community grants.

As you have probably heard, or read about, the Central Berkshire Regional School Committee is proposing to build a new Wahconah Regional High School. The estimated construction cost is \$71,871,147 with costs to the seven towns estimated at \$42,000,000. The estimated tax increase to Becket is \$0.24 per \$1,000 of valuation or approximately \$62.13 per year for an average house valued at \$255,700. This would be a 30-year commitment. On March 7<sup>th</sup> there will be a community meeting at the Becket - Washington School starting at 7:00pm I encourage all voters to attend so that you will be fully informed before the vote is held on April 6<sup>th</sup>.

At the 2018 ATM, an article was passed to allow the Town to lease space on the Johnson Road cell tower to increase our public safety and highway radio coverage. Unfortunately, the final negotiations were not cost effective for the town. The town anticipates building our own tower on town owned land at a much lower cost over a twenty year period and we would have total control.

The Ambulance Department has just received their new ambulance and the Fire Department has just received their new mini-pumper, Rescue #6, that will be assigned to Station #1 in the village.

Watch for the first Robin, then spring is on the way.

#### **Green Communities Update**

The 2018 Green Communities Designation Grant is complete and has been officially closed-out by DOER. The work completed this cycle was the heating, widows, lights and doors at the Highway Garage and also windows at Station #2.

As Bill noted above, we changed the solar bylaw to move into compliance which will allow us to apply for the GC Competitive Grants. We will look to replace the Town Hall HVAC to upgrade the heating and cooling system to improve efficiency. We also will replace the lights with LED lights.



## **COMMUNITY REMINDERS**

## Wahconah High School Building Project

There will be a presentation of the final proposal for a new Wahconah Regional High School on March 7, at 7:00pm at the Becket & Washington School. The cost of the project along with its tax impact for Becket will be presented at the forum. There will be a question and answer opportunity at this meeting. There is a snow date for the forum on March 21. This will be the last forum prior to the April 6 vote for the project.

#### Reminder about Motor Vehicle Excise Taxes

Any owner of a motor vehicle garaged in Becket and registered on January 1st should have received an excise tax bill. The due date was February 28th.

### **Unregistered Vehicles**

There have been several complaints regarding unregistered vehicles in the Town of Becket. Administration, Police and the Building Inspector have been working to address this issue. Below is the Town By-Law regarding unregistered vehicles, but in summary—no more than 1 unregistered vehicle is allowed.

#### **ARTICLE 17--TOWN BETTERMENT BY-LAWS:**

**SECTION 8.** The keeping of more than one unregistered automobile or truck assembled or disassembled, except by a person licensed under MGL Chapter 140, Section 59, on any premises shall not be permitted unless said automobiles or trucks are stored within an enclosed building. A permit to keep more than one unregistered automobile or truck on any premises not within an enclosed building may be granted by the Board of Selectmen, if it finds that such keeping is (1) in harmony with the general intent of this bylaw; (2) will not adversely affect the neighborhood; and (3) will not be a nuisance. All such permits granted shall limit the number of unregistered automobile and trucks to be kept on the premises by the permit holder, shall not run with land and shall be limited to a reasonable length of time. This article shall not apply to motor vehicles which are designed and used for farming. Who ever violates any provision of this bylaw shall be liable to a penalty of five (\$5.00) dollars per day for each day of violation commencing ten (10) days following receipt of written notice from the Board of Selectmen. (Adopted 5/11/85)
