Town of Becket Conservation Commission Meeting Minutes: December 20th, 2022

The Becket Conservation Commission (BCC) Meeting was held at the Becket Town Hall in compliance with the MA hybrid open meeting laws allowing applicants, contractors, and consultants to participate in person, virtually, or by audio.

The Chair Johnson called the December 20th, 2022 meeting to order at 5:00 p.m. having a quorum and indicated the meeting is being recorded. Chair emphasized that the meeting agenda included introduction comments that wouldn't be read and that it is the responsibility of each applicant and all others in attendance to review.

At 5:00 pm the Chair opened the meeting for public comment not on the agenda. Not hearing any comments, it was closed for public comment.

New Business:

1. **Request for Determination of Applicability**: Submitted by Scott McFarland for the work associated with the setting of a new distribution box and section of pipe at 134 Fireside Lane (Map 217, Lot 74) within the Buffer Zone of the Bank of Lancelot Lake.

Issues: add additional erosion controls to the proposed downhill side of the work area

Motion: to approve the Request for Determination with order of condition to place erosion controls on the downhill side of the work being permitted by Hank, seconded by Henry, motion carried unanimously 6-0. Only six commissioners present for this vote.

2. **Notice of Intent:** Submitted by Emily Pfeiffer (MassDEP #102-0471) for the removal of trees, construction of a gravel driveway, and installation of a shed and gazebo within Buffer Zone. As well as the removal of vegetation in a Bordering vegetated Wetland, Land Under Water and from the Bank of Longbow Lake, at 0 Long Bow Lane West (Map 213, Lot 72)

Issues: application was insufficient of information regarding the scope of work in the Buffer Zone and Resource area. Applicant was not present for the meeting. Commissioners could not make a decision.

Motion: Chair requested a motion for continuance to the May 23rd, 2023 meeting, motion by Jim, seconded by Henry, motion carried unanimously 7-0

3. **Enforcement Order:** Issued to Jack and Carol Attias of 43 Greenbrook Road (Map 207, Lot 55) for unpermitted removal of beaver dams on Pill Pond, alteration of several Resource Areas, and piling of materials in Resource Area and Buffer Zone.

Issues: will evaluate the disturbed are in April to determine any residual damage and if any restoration is required.

Motion: Chair requested a motion for continuance to the May 23rd, 2023 meeting, motion by Jim, seconded by Henry, motion carried unanimously 7-0

 - b. #102-205 issued on 06/22/2000 for a wetland trail installation.
 - c. #102-0361 issued on 02/23/2011 for Installation of Loop Road Bridge and Maintenance Facility.
 - d. #102-0417 issued on 10/11/2016 for Installation of Public Water System Pipe through BVW

Dear James Straub Lakes & Ponds Program

I am interested in reading your management plan more closely. Could you please send me a link to the plan?

It appears that responding to a small group of landowners is taking precedence over the stream below the dam, overall lake health and the maintenance of the public access. I hope a closer read of your plan will prove otherwise.

Seeing that the commission has permitted the removal of specified bladderwort species, should the plant cover %50 of the south cove on Buckley Dunton, I hope this will include maintenance of the Public launch, removal of invasive plants at the launch and your support in requesting a planned valve management that supports the natural flow regime one would expect to have in a high value Coldwater fishery.

I am very concerned and shared my concern with DRC that the Valve installed in the Dam at Buckley Dunton, to better manage flow regime into Yokum Brook, remained closed through much, if not all, of the drought conditions experienced in 2022.

It was disheartening that this is not an integral part of the States Dam management plan. This should not need oversight and should be an example of the States interest in riparian health, not an abuse of it. It should not be the Conservation commission's role to remind the State of its own laws and best management practices. They should be the first to follow and uphold the interest of the act and the health of its resources.

I was disappointed last evening that given all the changes proposed to the NOI that the commission did not require an updated version. The onus for "allowed actions" was put on and sadly accepted by the commission. This was not elegant. nor wisely done. If a morning meeting was held by Lakes & Ponds that substantially altered what was being asked, this should have been written up and an amended NOI proposed that evening.

I look forward to further conversations and collaborations for the benefit of our Lakes and Ponds. With consideration for the streams above and below impoundments and the <u>public</u> who enjoys and acts as steward for them all.
