1. Enforcement Order: Unpermitted tree removals within the Buffer Zone and on the Bank of Ward Pond at 0 Silver Leaf Drive (Map 214, Lot 132.2)

Issues: Trees cut down in the Buffer Zone without a permit

- 2. Request for Determination of Applicability: Submitted by Ron and Marily Sturgill for the work associated with the installation of a new septic system and bottomless sand filter within the Buffer Zone of a BVW at 77 Shawnee Shore Road (Map 204, Lot 98).

Issues: BOH has not approved a plan and has requested additional testing before reviewing, Chair Johnson requested BOH provide an approved plan before the Commission will review applicant's RDA

Issues: not able to perform a site inspection due to winter conditions and property access, Taconic Land Consultants did provide a written letter indication the work was performed to a lesser impact on the resource area and the Buffer Zone – photos were provide taken in the summer of 2023
