3. Administrator's input

- a. We have an opportunity for a grant for new HVAC for Town Hall
 - i. Up to \$250k grant for a possible heat pump based system; linked to a solar array

- 1. Grant opportunity for \$12,500 for a professional consultant to assess whether to go heat pump or propane based system
- 2. In February, we can apply for a grant for a propane based system if that is our best technology
- 3. We will need an updated energy audit for Town Hall
- b. We are working with Colonial Power on power aggregation
 - i. Aggregation plan posted on website today (7/11/2018)
- c. Working on 20 year vehicle replacement plan
 - i. FinCom can then meet with Department Heads
 - ii. Replacement needs to be based on overall economics rather than purely age
 - iii. Do we need a truck wash to lengthen their service life
- d. BM has a contract extension through October 31, 2018
- e. We have contracted with Housatonic Basin on the Route 20 spring
 - i. BM is keeping the Chester Town Administrator informed
- f. Town of Washington Fire/Ambulance
 - We have negotiated \$12,500 per annum for fire coverage with provisions for future increases
 - ii. We no longer have to provide backup ambulance coverage for Washington

4. Broadband Update

- a. CL has presented BOS a proposal for Matrix Design Group to take over broadband project
 - i. Pole survey process is an ongoing process and big unknown in make ready cost
 - ii. Matrix is posing to build a fiber optic based system that the town can purchase in 3 years
 - 1. Town is responsible for make ready costs
 - iii. Matrix is estimating a make ready cost of \$480 per pole which seems at odds with us having 22% red poles with an average replacement cost of \$4500 each
 - iv. Matrix was the original engineering company for WiredWest

5. Topics for future meetings

- a. Reserve and free cash policy
 - i. Need more than Chapter 90 funds for repaving
- b. County wide gas tax could be beneficial
- c. Becket could consider a meal tax
- d. OPEB liability analysis
- e. Capital purchase plan/Departmental budget challenges
- f. Tax and title sale
- g. Bank interest rates
- h. Are our costs for road districts covered by fees
