1. Review and approve minutes for December 03, 2015 meeting.

a. Acceptance of December 03 minutes moved by SL and seconded by MW. Passed unanimously.

2. Correspondence and transfers

- a. There are no transfers.
- b. There is an updated remote meeting policy.
- c. Regarding the annual holiday party by the Ladies Guild; the Board of Selectmen (BOS) approved the \$500.00. The Ladies Guild has not submitted a reimbursement for the money saying they thought they had raised the necessary funds to hold the party. As an aside EG said the downstairs was not left up to the proper standards by the party.
- d. EG stated the mileage reimbursement rate has dropped to \$0.54 / mile.

3. Town Administrator's input

- a. Still lacking 89 subscribers for Wired West to reach the goal. MBI issued comments on the RFP's.
- b. Tax bills were sent out.
- c. Sherwood Forest Neighbors Association, Inc. filed a petition to dissolve. \$184,000 in back taxes of land has been transferred to the Lake District.
- d. EG mentioned the FC has spent \$129 of its \$600.00 budget.
- e. EG mentioned the Ambulance Department will be looking at a new unit in 2018 and the Highway Department well be looking for a new front end loader in 2017. Ambulance is currently 5 years old.
- f. 2017 budget process is ongoing.
