Mr. Ronzio explains to Ms. Jull what she is requesting is not the purvey of the board but, she will need to speak to the Board of Health, Building Inspector and the Highway Dept. Ms. Jull thanked the board for their time and explanations.

- **3. Public Input:** Mr. Ronald Fairchild and Mrs. Laura Fairchild, co-owners and management team for Bonny Rigg Campground, wanted to thank the board for all they do and to let them know they are dealing with an internal issue regarding the campgrounds occupancy bylaws. Mr. Fairchild explains that an individual sent a letter to the Selectmen in regards to the town and campground bylaws. The campground bylaws are stricter than the Town's and it will be dealt with internally.
- 4. Old Business: Mr. Ronzio brings up short term rental bylaws. Mr. Blake was reticent to discuss the bylaw. Mr. Blake was concerned about who would enforce it. Mr. Ronzio states the Board of Health can deal with issues relevant to public health. Mr. Ronzio said the planning board could utilize bylaws that are currently in place in towns such as Lenox to draft a bylaw for Becket. Mr. Blake let the board know that there is a short term tax question being put together for the next annual town meeting. Mr. Ronzio stated that many people in Sherwood Forest are upset about the impact short term rentals do have on the community especially the beaches, lakes and common land. Ms. Krawet explains she was Chairperson of the short term bylaw committee and that not everyone could agree on enforcement procedures. Mr. Levy makes a statement about written complaints and how the Code Enforcer would have to act in accordance with matters brought before his attention. Mr. Lerner would like to go forward with the process of coming up with a short term bylaw.
- 5. Old Business: Attendance requirement Mr. Ronzio asks the board if we want to keep doing a hybrid meeting or go back to in person. Ms. Krawet says the board is managing to make it work and in the interest of transparency the meeting should stay as hybrid. Mr. Blake agrees and since Mr. Lerner won't be here for the winter this would work. Mr. Levy makes the motion to stay as a hybrid meeting and Mr. Levy seconds. Mr. Ronzio calls for a vote:

6. Correspondence: Mr. Ronzio states that the board received correspondence regarding the special permit application for the reopening the Becket General Store located at 30 Washington St. He further states one of the abutters has issues regarding parking and the right of way between the two (2) properties. Mr. Ronzio told the board a survey of the property most likely would be needed. The new owner has filed paperwork with the town for a special permit. Since next meeting will be held on Wednesday, Oct. 12, 2022, Mr. Ronzio states the board will need to get the certified letters sent out ASAP.
