Ms. Krawet wants to make sure that it is not a criticism of her because of the vote. Mr. Ronzio assures her that it had nothing to do with the vote that Ms. Krawet has a right to vote the way she feels. Mr. Ronzio apologizes to Ms. Krawet stating it was not directed at her. Mr. Blake makes the point that it is unusual that a board will all agree all the time. Mr. Lerner states that Mr. Ronzio wasn't casting aspersions against Ms. Krawet. Ms. Krawet accepts the explanation.

Ms. Lei Ann Ellis asks the board about the potential transfer of the permit from FFD Enterprises MA Inc. to Himalayan High. Ms. Ellis believes the permit can't be transferred. Mr. Ronzio replies that the Planning Board doesn't issue the license the Select Board does. Mr. Ronzio looks up the Massachusetts General Law that states it can be transferred. Ms. Ellis asks the board to vote on amending the special permit. Mr. Ronzio asks the board if they find it necessary all concur that they do not need to. Ms. Ellis thanks the board for their time. Mr. Ronzio lets the board know that the Select Board has signed the host agreement with Himalayan High and it has been signed by Himalayan High and FFD Enterprises.

Mr. Ronzio states that one of the principals is a Veteran and when the application reaches the CCC they will verify the status of the applicant being a Veteran owned business.
