1. Call to order

BE called the meeting to order at 7:00pm. He indicated that the SB was recording the meeting.

2. Pledge of Allegiance

BE led the Pledge of Allegiance.

3. Broadband Update and Select Board to discuss and possibly vote on policies and decisions relating to the Broadband Project

ML read MLP Manager Bob Gross's update:

- 1. We are continuing to connect new premises.
- 2. There are still problems with MakeReady but fortunately none will interfere with the FSAs to be connected thru winter. Bill Ennen and the state are actively involved in resolving the problem.
- 3. Except for a few areas where the MR issues exist, the strand should be complete installed the first week of December. This will enable us to identify any missed MR issues.
- 4. The contractors who do the underground work will stop the middle of December. On a very limited basis Whip City Fiber will send in a crew, if possible.
- 5. We asked WCF to focus on those underground installations which require plowing. Kent Lew will work with a couple of volunteers and install drop cables where there is usable conduit to maximize the number of underground installations that can be done before the ground freezes.
- 6. WCF has told us that in some cases, where the underground work has not been done, that they can install a temporary aerial connection. There is an additional \$150 cost. When the Ad Hoc Group meets next week and discusses this issue, I think our recommendation will be that the homeowner should be responsible for the cost.
- 7. Because of certain MakeReady problems, which have been corrected, a section of FSA09 will not be turned over to us until the end of the year rather than the beginning of November. As a consequence, the FSA08 is pushed back a week and installations will start after the first of the year. BE commented that his premise located in FSA09 was hooked up today and he is pleased with the improvement.
- 4. 7:05pm Pursuant to Massachusetts General Laws, Chapter 140, Section 157, the Select Board will conduct a Public Hearing in response to a dog complaint to determine whether the dog, is a nuisance or dangerous dog, in accordance with Section 157, other

applicable laws and the by-laws of the Town of Becket. Said canine is housed at 199 Maid Marion Lane, Becket, MA 01223

BE read the public hearing notice for the above captioned agenda item. At 7:07pm, BE commenced the Public Hearing. BE read Robert Crosier's letter of complaint contending that the dogs residing at 199 Maid Marian Lane run loose off their property and bark incessantly and therefore the SB should deem them a nuisance.

BE stated that he drove past 199 Maid Marian Lane twice and found the dogs in a fenced-in area.

Animal Control Officer Nicole Miller read her report outlining her investigation in response to Mr. Crosier's complaint. On 10/30/2021 Nicole issued a citation in the amount of \$25.00 to Ms. Drohan of 199 Maid Marian Lane for violation of Town Bylaw Article 20, Section 4 Disturbing the Peace due to that three dogs were outside upon her arrival and barked in a fenced in area of the yard located at 199 Main Marian Lane.

Nicole concluded:

- There is insufficient evidence to regard the three dogs at 199 Maid Marion Lane a nuisance, as defined by law. She observed that the dogs barked when a car or a person passes but became quiet when the perceived "threat" left the area. She reports no complaints from other neighbors and she did not observe the dogs running free in the area.
- The Town Clerk had confirmed that three dogs located at 199 Maid Marian and two
 dogs located at 14 King Arthur are not registered and therefore she is warning all parties
 that each dog must be registered in the Town of Becket per State Statute Chapter 140,
 Section 141 and they have 30 days to do so or will be fined \$50.00 for each dog.

Kelcie Drohan stated that although her dogs run unleashed inside a fenced in yard on her property, they do not run loose off her property. In response to the complaint about barking, she has reduced her dogs' outdoor time. She stated that her dogs are not vicious and believes the barking falls within the normal scope of dog behavior: They bark if someone is passing by or on her property, and they stop when the person/vehicle has left. She regards Mr. Crosier's complaint as petty harassment and she does not feel safe encountering him with her children in her neighborhood: he walks his two dogs with a baseball bat. She stated that Mr. Crosier had told her that his dogs will eat her dogs.

ML expressed concern about the aggressive wording in Mr. Crosier's letter ("People walking by with their dogs won't end well eventually....".

BE moved to dismiss the complaint relating to the dogs located at 199 Maid Marian Lane. ML 2nd. Motion carried.

BE closed the public hearing at 7:20pm.

Tax Title Custodian Christine Bleau opened the sole sealed bid she received:

Sherwood Forest Lake District (submitted by its Representative Bob Ronzio) \$7,610.09; \$500.00 deposit (not a personal check) was received The bid satisfied the \$7,600.00 minimum bid requirement

ML moved to approve Sherwood Forest Lake District's bid in the amount of \$7,610.09 pursuant to the provisions of Massachusetts General Laws, Chapter 60, Section 77B for purchase of Pine Dale Circle Parcel (Map 219, Lot 133). BE 2nd. Motion carried.

9. SB to review and vote on approval of Board of Assessors Tax Stuffer

unanimous.

- The Otis Police Chief resigned. Otis Officials approached BC to inquire if the TOB would be
 amenable sharing a Police Chief with Otis. BC reported that Becket's Police Chief is amenable
 to considering this. It was agreed that BC will discuss this matter with Otis officials and report
 to them.

12. Select Board's Comments and Announcements

ML reported he ordered signs for the entrance of the Esau Heel's trail. It was agreed that the Highway Department will install them.

Per BE's suggestion, the SB agreed to reposition the Town's cemetery signs to face traffic in both directions. The signs will change from one to two-sided.

ML initiated discussion regarding James Levy's letter (listed under Correspondence) relating to Emergency Preparedness. BE indicated that due to that the town has an Emergency Management Director (Police Chief McDonough) and many protocols in place through Berkshire County Sheriff's Office and MEMA (including shelters: Town Hall, Fire Stations, Schools, YMCA & special communications), he does not agree a committee is needed. It was agreed that ML will contact Kris McDonough to discuss the possibility of setting up a ham radio.

13. Any other business to come before the Board

The SB will have an 2021 Annual Town Report Cover Photo Contest

As done in the past, the SB agreed to close Town Hall 1pm on Wednesday, November 24th. Unless inclement weather requires attention to the roads, this will extend to the Highway Department.

Based on the Ambulance Director's letter of recommendation, <u>ML moved to approve the amended payrate effective 11/16/2021 for Ambulance Department employee Max Koivisto to \$19.29 per hour for completion of Advanced EMT. BE 2nd: Motion carried.</u>
