

**Article 3:** To see whether the proprietors will vote to raise and appropriate \$10,950 to install a new mailbox shed, accommodating 2 mailbox clusters donated by the Becket Post Office. Comprising the amount is the cost of the Shed (\$5,000), new cement (3,000), excavating and stone (\$2,500) and electrical work to add solar lighting (\$450.00).

**Article 4:** To see if the proprietors will vote to approve the request of Wesley P. Moore and Susan M. Askins ("Moore/Askins") to exclude their real property located at Fairway Drive and Silverleaf Drive in the Sherwood Greens Road Improvement and Maintenance District (the "District") from taxation by the District based on the following:

The Special Act creating the District is set forth in Chapter 31 of the Acts of 1997, as amended by Chapter 235 of the Acts of 2006 (together, referenced as the "Special Act"). Moore/Askins own real property located in the District as set forth in a deed recorded in the Berkshire Middle District Registry of Deeds in Book 7044, Page 231, (the "Property"). Section 19 of the Special Act creates a procedure for exclusion from the District provided "such estate is so situated that it can receive no benefit from the repair and maintenance provided in the district." At a duly noticed meeting of the Prudential Committee on April 21, 2022, called for the purpose of voting on the application of Moore/Askins to have the Property be excluded from the District under Section 19, the Prudential Committee voted by a vote of 4 to 0 not to exclude the Property because the access to the Property is over the streets maintained by the District. FURTHERMORE, as provided in Section 19 of the Special Act, the petition to exclude the Property is hereby included in the Warrant for the Annual District Meeting, with a record of the vote by the Prudential Committee. Copies of the petition and the record of the vote of the Prudential Committee are on file with the District Clerk and available by request.

**Prudential Committee recommends** 

2/3 vote required

**Article 5:** To entertain nominations and cast votes in the Sherwood Greens Road Improvement and Maintenance District Road election to fill vacancies and renewals of district officers as follows:

- 1 Member Prudential Committee, three-year term (Vacant)
- 1 Member Prudential Committee, one-year term (Vacant)

And you are further directed to serve this warrant by posting attested copies at the usual places designated by the District at least fourteen (14) days before the time of holding said meeting.
