


## **Sherwood Forest Road Maintenance District**

The SFRMD Prudential Committee meeting will begin at 8:45 AM and the SFLD Prudential Committee meeting will commence at 10:00 AM provided we have a quorum for each meeting. These meetings are being held in accordance with Governor Healey's extension guidelines\* for remote meetings thru March 31, 2025 set forth as part of a nearly \$400 million bond bill that was signed on March 29, 2023.
