

SFLD/SFRMD TELECONFERENCE PUBLIC ANNOUNCEMENT

Dr. Howard G. Lerner, as the chair of the SFLD district, has asked me to publicly inform everyone about the upcoming **Sherwood Forest Lake District Meeting** & **Sherwood Forest Road Maintenance District Meeting** scheduled for this Saturday, May 11, 2024. The SFRMD Prudential Committee meeting will begin at 8:45 AM and the SFLD Prudential Committee meeting will commence at 10:00 AM provided we have a quorum for each meeting. These meetings are being held per Governor Healey's extension guidelines* for remote meetings through March 31, 2025, set forth as part of a nearly \$400 million bond bill that was signed on March 29, 2023.
