- 1. Call to Order- Victoria Bleier calls the meeting to order at 6:03 PM. Ms. Bleier introduces the Board members present

Ms. Bleier asks Mr. Mazzantini to address the board.

Mr. Mazzantini displays the site plan to the board. Mr. Mazzantini states the existing house is non-conforming on the rear setback. Mr. Mazzantini states the new plan will create a new non-conformance on the side set back to a vacant lot next door, and will eliminate the existing non-conformance to the rear on the lake. Ms. Bleier asks if the existing house will be taken down entirely. Mr. Cellura states the existing house will be fully demolished. Mr. Mazzantini states the footprint of the home will be minimally changed, increasing the distance from the abutter on the right and moving the house toward the parcel that is a right of way to the lake. Ms. Bleier asks if the plan has been submitted to the Conservation Commission. Mr. Mazzantini states it was brought to the Conservation Commission, the septic layout was changed according to their direction.

Ms. Bleier asks if the applicants have any questions for the board. Mr. Mazzantini states they just wanted to hear any possible concerns before the hearing scheduled next month.

Ms. Bleier asks the board members if they would like to do a site visit. The board arranges to meet Mr. Cellura at the site on Saturday April 8, 2023 at 8:30 AM.
