# **Zoning Board of Appeals Meeting Minutes**

#### Call to order

The meeting began at 7 p.m.

#### 1. Review and Acceptance of previous Meeting Minutes

No meeting minutes were presented for approval.

## 2. Board to discuss and appoint interim recording member

Karen will talk to the Town Administrator to request administrative support for the ZBA until the town fills the Clerk of Committees vacancy.

# 3. Lorraine and Dave Corriveau, 29 Lancelot lane, request to review previously approved special permit

Karen reported on her meeting with the Building Inspector regarding Lorraine and Dave Corriveau's request for the ZBA to review the special permit that the ZBA granted and filed in the Town's Clerk's office on 5/19/2015 for property located at 29 Lancelot Lane.

- To date, the Corriveaus have not filed the approved special permit with the Registry of Deeds. Karen advised that a property owner must file its own approved special permit with the Registry of Deeds before the Building Inspector may issue a Building Permit for the work proposed in the special permit.
- The Corriveaus had specified that they are considering modifying the proposed plans of the Special Permit Application with similar plans containing a smaller footprint. The ZBA advised that once a special permit application is granted, the ZBA does not have a mechanism to change the proposal even if the plans of the new proposal yield a smaller footprint.
- They were advised to either build something that could be permitted by right, or file a new application with the ZBA for the proposed new project.

Discussion ensued regarding non-conforming lots (29 Lancelot Lane falls into that category) and Town of Becket's Zoning Bylaws 3.4.4. The ZBA recommended that the Corriveaus discuss their new proposal and plans with the Building Inspector who would determine if a special permit is required. The ZBA explained that the proposal in the previously approved special permit may not be altered or used for a different project.

Mr. and Mrs. Corriveau indicated that they are not certain if they are able to find the original special permit documents the Town Clerk had provided to them. The Town Clerk will research if the Registry of Deeds will accept a certified copy in lieu of the original.

The ZBA advised that a special permit expires two years after it is filed in the Town Clerk's Office and this means that construction must commence within that time frame. The Board noted that the Corriveau's special permit will expire if work on the approved project does not begin by 5/19/2017.
